ORDER

Sri.Raju Abraham M.L.A representing Ranni Constituency proposed to take up the work '**Improvements and providing 20mm thick chipping carpet to Jenimol Road for the branch road of Vallaripoika -Oottukulam Road km 0/150'** in Kottangal Grama Panchayat under LAC-ADS at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** read as 2nd paper above. The Chief Engineer, PWD, Roads & Bridges furnished detailed estimate for the work read as 3rd paper above for according Administrative Sanction and Special Sanction. Kottangal Grama Panchayat Committee passed resolution entrusting PWD to execute the work as deposit work as per 5th paper read above.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work '**Improvements and providing 20mm thick chipping carpet to Jenimol Road for the branch road of Vallaripoika -Oottukulam Road km 0/150'** in Kottangal Grama Panchayat under LAC-ADS of Sri.Raju Abraham M.L.A representing Ranni Constituency at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** with Special Sanction to take up the work for execution, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders, subject to the condition that the work should be executed through Public Works Department as deposit work.
