### O R D E R

As per the Government Order read as 1<sup>st</sup> paper above administrative sanction was accorded to Kudumbasree to implement NRLM in the state. The project sanctioning committee of the state under Aajeevika Skills (NRLM) had recommended eight individual project from eight Programme Implementing Agencies (PIAs) for skilling & placing rural youth in the state.

2. The Executive Director, Kudumbasree informed that, since the State hasn't fulfilled the Annual Action Plan criteria, the state has been designated as Non- Annual Action Plan state and the Empowered Committee of Ministry of Rural Development sanctioned the individual project based on the recommendation of the Project Sanctioning Committee.

3. As per the letter read as 5<sup>th</sup> paper above, Executive Director, Kudumbasree has requested to release the state share of Rs.18,50,65,376.00

(Rupees Eighteen Crores fifty lakh sixty five thousand three hundred and seventy six only).

4. Government have examined the case in details and are pleased to accord Administrative Sanction to Executive Director, Kudumbasree to release Rs.4,62,66,344/- (Four Crore sixty two lakh sixty six thousand three hundred and forty four only) as State share (25%) under the Head of Account 2501-06-197-48-04. NRLM General (PV) during the Financial Year 2014-15.

5. The Executive Director, Kudumbasree will ensure that the fund is utilized only for the purpose for which it is sanctioned.
