The Grama Panchayats passed resolutions entrusting Public Works Department to execute the works as deposit works as per 5<sup>th</sup> paper read above.


executed as deposit works through PWD. The Chief Engineer, Local Self Government Department should take further action to deposit the required amount to PWD as envisaged in the circular read above.
