### **ORDER**

1. The 10<sup>th</sup> instalment of the General Purpose Fund (GPF) for the year 2014-15 to the Local Self Government institutions (LSGIs) after various financial adjustments already in position, is sanctioned by the Finance Department vide order read as 3<sup>rd</sup> paper above.

Accordingly, sanction is accorded for issuing Letter of Authority in form Annexure C-1 of the G.O read as 1<sup>st</sup> paper above to the Local Self Government (LSGs) and to the treasuries for the release of the net amount shown in annexure 2 to the G.O read as 3<sup>rd</sup> paper above by the respective controlling officers / sub controlling officers.


