As proposed ^{by} Sri.C.F.Thomas M.L.A representing Changanassery Constituency, the Chief Engineer, PWD, Roads & Bridges furnished detailed estimate for the work '**Construction of Uzhathilpady-Vallyara road**' in **Paippad Grama Panchayat** at an estimate cost of **Rs.30,00,000/-(Rupees Thirty Lac only)** under LAC-ADS read as 2nd paper above for according Administrative Sanction and Special Sanction and Paippad Grama Panchayat Committee passed resolution in this regard as per 5th paper read above.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work 'Construction of Uzhathilpady-Vallyara road' in Paippad Grama Panchayat at an estimate cost of **Rs.30,00,000/-(Rupees Thirty Lac only)** proposed under LAC-ADS of Sri.C.F.Thomas M.L.A representing Changanassery Constituency with Special Sanction to take up the work for execution, following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government orders, subject to the condition that the work should be executed as deposit work through Public Works Department. The Chief Engineer, Local Self Government Department should take necessary action to deposit the required amount to PWD as envisaged in the circular read as 4th paper above.


