As per the letter read as 2<sup>nd</sup> paper above sanction was accorded by Ministry of Rural Development for the release of Rs.10.0350 crore (Rupees Ten Crore Three Lakh Fifty Thousand only) as 2<sup>nd</sup> instalment of central share during the financial year 2013-14.

2. Subsequently Executive Director, Kudumbashree as per the letter read as 4<sup>th</sup> paper above has requested to release Rs.3.3450 Crore (Rupees Three Crore Thirty Four Lakhs Fifty

Thousand only) as state share of NRLM corresponding to central share during the financial year 2013 - 14
