ORDER

As proposed by Adv.Mons Joseph, M.L.A representing Kaduthuruthy Constituency under LAC-ADS for the year 2014-15 as per the reference read as 2nd paper above, the Chief Engineer, PWD(R&B) furnished detailed estimates of the following 7 road works at a total estimate cost of **Rs.170,00,000/- (Rupees One Hundred and Seventy Lac only)** for according Administrative Sanction and Special Sanction read as 3rd paper above.


