ORDER

As per the Government order read as 1st paper above, General Education Department issued Administrative Sanction for the work "**Construction of Auditorium at Government LPS Kodaly**, at an estimate cost of **Rs.53,70,000 Lakhs** (Rupees fifty three lakhs seventy thousand only) under **LAC-ADS of Prof.C.Raveendranath, MLA, Puthukkad Legislative Assembly Constituency** debiting the expenditure under the Head of Account 4202-01-800-88 projects under LAC-ADS(NP)

Prof.C.Raveendranath MLA, in his letter read as 2nd paper above has pointed out that the Government Order read as 1st above is silent on the Department to which the executing agency **COSTFORD** has to execute the agreement, the work could not be implemented and requested to do the needful to start the work. Accordingly the Finance Department as per their note 3rd read above has requested General Education Department to cancel the Administrative Sanction accorded in the Government Order read as 1st paper above and to transfer the file to Local Self Government Department for issuing revised Administrative Sanction under the **Head of Account 4575-00-800-96 project under LAC-ADS** . The General Education Department as per the Government Order read as 4th paper above, has canceled the Administrative Sanction accorded for the work "**Construction of Auditorium at Government LPS Kodaly**", read as 1st paper above and transferred the file

to Local Self Government Department for issuing revised Administrative Sanction for the work under the Head of Account 4515-00-800-96 (NP).

Having examined the matter in detail Government are pleased to accord revised Administrative Sanction for the work "**Construction of Auditorium at Government LPS Kodaly**, at a total estimate cost of Rs. **Rs.53,70,000 Lakhs** (Rupees fifty three lakhs seventy thousand only) with special sanction to take up under the LAC-ADS of **Prof.C.Raveendranath, MLA, representing Puthukkad Legislative Assembly Constituency** following all departmental formalities and in tune with the guidelines issued in G.O(P)332/2012/fin dated: 11/06/2012 and subsequent government orders.

The expenditure in this regard shall be debited to the Head of Account "4515-00-800-96 Projects under LAC-ADS (NP)". The Chief Engineer, Local Self Government Department or Executive Engineer concerned shall execute an agreement with **COSTFORD**, the executing agency.
