### ORDER

As proposed by **Sri.G.Karthikeyan(Late), former Speaker, Kerala Legislative Assembly and MLA representing Aruvikkara Constituency** under LAC-ADS for the year 2014-15, the Chief Engineer, PWD(R&B) forwarded detailed estimate of the work '**Improvements to Chettiyampara-Karakkamthodu-Panacode Road from Km 0/000 to 3/200 in Tholikkode Grama Panchayat**' at an estimate cost of **Rs.260,00,000/- (Rupees Two Hundred and Sixty Lac only)** as per the reference read as 3<sup>rd</sup> paper above to accord Administrative Sanction and Special Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work '**Improvements to Chettiyampara-Karakkamthodu-Panacode Road from Km 0/000 to 3/200 in Tholikkode Grama Panchayat**' proposed under LAC-ADS of **Sri.G.Karthikeyan(Late), former Speaker, Kerala Legislative Assembly and MLA representing Aruvikkara Constituency** for the year 2014-15 at an estimate cost of **Rs.260,00,000/- (Rupees Two Hundred and Sixty Lac only)** with Special Sanction to take up the work for execution as deposit work through PWD subject to the resolution passed by the


