ORDER

As proposed by **Sri.G.Sudhakaran, MLA representing Ambalapuzha Constituency**, the Chief Engineer, PWD(R&B), Thiruvananthapuram, has furnished detailed estimate of the work '**Improvements to Road from Karumadi to Padaharam Road from Ch 0/000 to 0/750 in Ambalapuzha South Grama Panchayat**' under LAC-ADS for the year 2014-15 at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** as per the reference read as 2nd paper above to accord Administrative Sanction and Special Sanction.


