ORDER

Sanction is accorded for the deputation of Smt. Prasanna Kumari.P.N. Personal Assistant, General Administration Department, Government Secretariat as Confidential Assistant, in the District Panchayat Office, Ernakulam as a special case for a period of one year on usual terms and conditions of deputation and also subject to the following conditions as stipulated in the Government Circular read above.

“As per Rule 140(c), Part I Kerala Service Rules the Officer on foreign service will be relieved of his duties on the date of expiry of the sanctioned period unless the competent authority has, with requisite approval, extended the period of deputation. in writing, prior to the date of its expiry. In the event of the officer overstaying he/she will be liable to disciplinary action and the period of overstay will not be counted for the purpose of pension and that any increment due during the period of overstay will be deferred with cumulative effect, till the date on which the officer rejoins his /her parent cadre. No ex-post facto approval for regularization of overstay on foreign service will be allowed. The officer will be precluded from drawing pay and allowances from the date on which the sanctioned term of Foreign Service expires. The period of leave, if any, taken by an officer, as per rules applicable to him / her, on the conclusion of foreign service and before joining his / her post will not be considered as an overstay under this sub-rule.

The provisions of this sub-rule have been made applicable to an officer on deputation from one service to another or from one Department to another within the same service."
