**O R D E R**

1. In the circumstances reported by the Commissioner for Rural Development in the letter read above ex-post facto sanction is accorded to the Project Directors, Poverty Alleviation Unit of the participating District Panchayats to provide assistance to the beneficiaries deputed to Regional SARAS at Kolkatta from 31.01.15to12.02.15 subject to the following terms and conditions:

- (i) Each beneficiary will be paid to and fro Travel Expenses limited to Sleeper Class rail fare and actual rail freight charges, and porter charges of the products to be brought to the venue at Kolkatta
- (ii) An amount of Rs.200/- (Rupees Two hundred only) will be paid to the beneficiaries for meeting incidental expenses during the to and fro journey.
- (iii) A lump sum amount of Rs.1000/- (Rupees One thousand only) will be paid to each beneficiaries/each representative of SHG for meeting the expenses towards incidental expenses and local transport at Kolkatta
- (iv) The expenditure will be met from the balance SGSY fund available with the respective Poverty Alleviation Unit. Project Directors will release an advance of Rs.2000/- (Rupees Two thousand only) each to the participant, subject to final adjustment on production of certificate of participation from Ministry of Rural Development/Charge Officers of the State.

- (v) The beneficiaries will be solely responsible for the transportation and sale of products at Kolkata. The Poverty Alleviation Units or State Government will not be responsible for any loss sustained to the artisan during the journey or at the fair.
- (vi) Expost facto sanction is also accorded for the deputation of Sri . K. Vimal Raj , Block Development Officer , Panoor Block Kannur as State Co- ordinator for the Saras fair at Kolkata & sanction is also accorded to meet the TA/DA and other expenses of the officer from the DRDA administration fund
