ORDER

Smt.Radhamony was appointed as Part Time Sweeper on casual basis at the Community Health Centre, Neendakara as per the resolution of the Block Panchayath Committee on 08.07.2002. She had been terminated from the service on 25.12.2005 by the Superintendent of Government Hospital in pursuance of the instruction from Block Panchayath. Smt.Radhamony filed T.A.-6084/2012 (WP(C) No.15390/08 of Hon'ble High Court of Kerala) before the Kerala Administrative Tribunal claiming for regularizing her service in view of the order read as 1st paper above. The Hon'ble Administrative Tribunal in its Order read as 2nd paper above directed the Government to pass orders on the claim of the applicant for regularization as provided in paragraph 10 of the order read as 1st paper above, within three months from the date receipt of a copy of this order. The Hon'ble Administrative Tribunal allowed 3 months time from 09.04.2015 for finalising the order.

As per the letter read as 3rd paper above, the Commissioner for Rural Development has forwarded proposals for creation of a post of Part Time Contingent Sweeper in the Community Health Centre, Neendakara and for regularization of the service of Smt.Radhamony to that post.

Government have examined the matter in detail and are pleased to accord sanction to create a post of Part Time Sweeper in the Community Health Centre, Neendakara and to regularize the service of Smt.Radhamony as Casual Sweeper in that post w.e.f. the date of Order. The vacancy arising out on the retirement of Smt.Radhamony should be filled up only through the Employment Exchange. Thereby the direction contained in the Order of the Hon'ble Kerala Administrative Tribunal in T.A.6084/12 (WP(C) 15390/08 of Hon'ble High Court of Kerala) is complied with.
