As proposed by Sri. P.K.Kunhalikutty, Minister for Industries and Information Technology and M.L.A representing Vengara Constituency as per the reference read as 2nd paper above, the Chief Engineer, PWD, Buildings, Thiruvananthapuram has furnished detailed estimate of the work '**Construction of New Building for Parappur Yuvajana Sangham Library in Parappur Grama Panchayat**' under LAC-ADS for the year 2014-15 at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** to accord Administrative Sanction and Special Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work '**Construction of New Building for Parappur Yuvajana Sangham Library in Parappur Grama Panchayat**' proposed under LAC-ADS of Sri. 
