ORDER

As per the reference first cited Government introduced Electronic Ledger Account (ELA) system facilitating Government departments/PSUs to ensure efficiency and continuity in utilisation of funds.

In the reference second cited Government issued Administrative Sanction for Construction of building for newly formed six Block Panchayaths for an amount Rs:500.00000 Lakhs (Rupees Five Hundred Lakhs Only). Since the sanctioned amount could not be expended in full during the last financial year, Government vide reference third cited have permitted to post an amount of Rs:128.44 Lakhs (Rupees One Hundred and Twenty-Eight Lakhs and Forty-Four Only) to the Electronic Ledger Account (ELA).

3. Commissioner for Rural Development vide reference read as 5th paper above has requested to release an amount of Rs.50,73,382/- for the construction of Parappa Block Panchayath Building from Rs.1,28,43,927/- posted in Electronic Ledger Account.

4. Government therefore accord sanction to release an amount of Rs:50.73382 Lakhs (Rupees Fifty Lakhs and Seventy-Three Thousand Three Hundred And Eighty-Two Only) for the implementation of the above components of the scheme.

5. The expenditure will be met from the budget provision under the head of account 2515-00-197-36-01-00-00-P-V during the financial year 2015-16 before 30th September.
