ORDER

As per the Government order read as 2nd paper above administrative sanction has been accorded for the work Construction of building for Engampuzha Bus Stand amenities in Puthupady Grama Panchayat in Kozhikkode District at an estimate cost of Rs 45,00,000/- (Rupees Fourty Five Lac only) under the LAC-ADS of **Sri. Moin Kutty MLA** representing **Thiruvambadi Constituency**. The work has to be executed as a deposit work through Public Works Department. But the Government order read as 2nd paper above is silent on the same. The Chief Engineer, Local Self Government, Thiruvananthapuram in his letter read as 3rd paper has requested Government to modify the orders so that fund can be released to PWD from the H/AC 4515-00-800-96 NP operated by Chief Engineer LSGD.

Government have examined the matter in detail and are pleased to clarify that the work Construction of building for Engampuzha Bus Stand amenities in Puthupady Grama Panchayat in Kozhikkode District for which administrative sanction was accorded for an estimate cost of Rs 45,00,000/- (Rupees Fourty Five Lac only) as per the Government Order read as 2nd paper is to be executed as deposit

work through Public Works Department following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent government orders subject to resolution passed by the concerned local body in this regard .

The expenditure in this regard shall be debited to the Head of Account " 4515-00-800-96 Projects under LAC-ADS (NP)".The Chief Engineer, Local Self Government ,Department,Thiruvananthapuram should take necessary steps to deposit the required amount to PWD as envisaged in the circular read above.


