As proposed by **Dr.T.M.Thomas Issac MLA representing Alappuzha Constituency** under LAC-ADS for the year 2014-15 as per the letter read as 2nd paper above, the Chief Engineer, PWD(R&B) Thiruvananthapuram has furnished detailed estimate of the work '**Improvements to Kuttara-Valiyaporil road in Mannancherry Grama Panchayat**' at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction.


