**ORDER**

As per Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> paper above, State Government have enhanced the amount of assistance for IAY beneficiaries from 2011-12. The assistance given to General, Scheduled Caste, Scheduled Tribe IAY beneficiaries was Rs.75,000, Rs.1 lakh and Rs. 1.25 lakh respectively. This amount has been enhanced to Rs.2 lakh for General and Scheduled Caste beneficiaries and Rs.2.50 lakhs for Scheduled Tribe beneficiaries. The amount over and above the unit cost fixed by Government of India has to be met by Grama, Block, District Panchayats. As the three tier panchayats found it difficult to earmark sufficient fund from their Plan funds, State Government decided to give additional financial assistance to three tier Panchayats.

Government have examined the matter in detail and are pleased to sanction an amount of Rs.500 Crore as the additional Financial support by Government of Kerala for Indira Awaas Yojana scheme. Out of the total 500 Crore sanctioned, sanction is also accorded for the release of Rs.300 Crore (Rupees Three Hundred Crore only) under the head of account 2501-01-197-48-01 IAY (general) for the year 2015-16 to the treasury Savings Bank account No.119 of District Treasury, Thiruvananthapuram in the name of Commissioner for Rural Development.

The amount will be utilized for meeting the additional assistance component from Government of Kerala.

Out of the remaining amount, Rs.100 Crore will be released in December, 2015 and Rs.100 Crore will be released in January, 2016.

Utilization certificate for 80% of each installment will be submitted by Commissioner for Rural Development before the release of the subsequent installment.
