ORDER

In the application read as 4<sup>th</sup> paper above, Shri. Kennedy John, Assistant Town Planner,District Town Planning Office, Idukki has applied for an amount of Rs.150000/- (One lakh fifty thousand only) as Interest Free Medical Advance (IFMA) for his Cardiac Treatment (PTCA with Tenting treatment) at Medical College Hospital, Kottayam. The Chief Town Planner has recommended the application as per his letter read as 5<sup>th</sup> paper above. Dr.V.L.Jayaprakash, Additional Professor, Department of Cardiology, Medical College Kottayam has certified that total approximate expenditure for the treatment is Rs.150000/- (One lakh fifty thousand only).

Government have examined the matter in detail and are pleased to sanction an amount of Rs.150000/-(One lakh fifty thousand only) as Interest Free Medical Advance (IFMA) to Sri. Kennedy John, Assistant Town Planner for his Cardiac treatment surgery at Kottayam Medical College subject to the conditions specified in Government Orders read as 1<sup>st</sup> to 3<sup>rd</sup> paper above and also on the following conditions.The expenditure in this regard shall be debited under Head of Account "7610-00-800-95(01) IFMA to Gazetted Officers" in the current year's Budget.

- i. The Utilisation Certificate duly countersigned by the Medical officers of the Institution should be produced within 3 months from the date of drawal and the advance shall be settled within 6 months from the date of drawal. In case of default penal interest @12% will be charged.
- ii. Necessary entries shall be made in the Service Book of the loanee regarding Interest Free Medical Advance with amount , number and contingent bill number, number

- and date of Government Order etc. of the drawal of the loan.
- iii. In case of non-drawal/cancellation of Interest Free Medical Advance the said fact may also be reported to Government without fail.
  - iv. Date of encashment should be intimated.
  - v. Unutilised amount if any should be refunded immediately.
