ORDER

IRDP/SGSY Trade fair is conducted every year by Rural Development Department during Onam Festival with a view to facilitate marketing of IRDP/SGSY product. The Commissioner for Rural Development as per the letter read above has informed that the Rural Development Department is proposed to organize trade fair in all district except in Wayanad, Idukki, Kottayam & Kasargod from 22.08.15 to 26.08.15 by meeting the expense from SGSY fund with Poverty Alleviation Unit amounting to Rs.34,57,090/- (Rupees Thirty four lakhs Fifty seven thousand and Ninety only) available with districts as given in annexure.

2) During the current financial year an amount of Rs Ten Lakhs is provided under the H/A.2515-00-102-41(02) plan for the assistance to District level marketing outlet & rural product. Hence Commissioner has requested for sanction to sanction Rs.6 lakhs (Rupees Six lakhs only) from Rs.10 lakhs sanctioned under the Head of Account 2515-00-102-41 (02) .

3) Government have examined the case in details and are pleased to accord expost facto sanction to meet Rs.34,57,090/- (Rupees Thirty four lakhs fifty seven thousand & Ninety only) from the unutilized SGSY fund kept with Poverty Alleviation Units as detailed in

annexure given and also to expend Rs.6 lakhs from the Head of Account 2515-00-102-41(02)
for the conduct of IRDP SGSY trade fair from 22.08.15 to 26.08.15
