**ORDER**

Sri.Vinod.C, Village Extension Officer Grade II, Block Development Office, Manjeshwaram in his application read as 4<sup>th</sup> paper above has requested Government to sanction an amount of Rs.2,40,000/- (Rupees two lakh forty thousand Only) as Interest Free Medical Advance for his Acute Leukemia treatment at the Regional Cancer Centre, Thiruvananthapuram. The Commissioner for Rural Development has also recommended the application of Sri.Vinod.C, Village Extension Officer Grade II, vide letter read as 5<sup>th</sup> paper above.

Government have examined the matter in detail in the light of the Government Orders read above and are pleased to accord sanction for an amount of Rs.1,50,000/- (Rupees One Lakh Fifty Thousand only) as Interest Free Medical Advance to Sri.Vinod.C, Village Extension Officer Grade II, Block Development Office, Manjeshwaram for his Acute Leukemia treatment at the Regional Cancer Centre, Thiruvananthapuram by debiting the expenditure under the head of account "7610-00-800-95(02) IFMA to Non Gazetted Officers" in the current year's Budget, subject to the conditions specified in the Government Orders read above. The Utilization Certificate duly countersigned by the Medical Officer of the Institution should be produced within 3 months from the date of drawal and the advance should be settled within 6 months. In case of default, penal interest @ 12% will be charged. Necessary entries regarding Interest Free Medical

Advance will be made in the Service Book of the loanee with amount, number and date of Government Order, Contingent Bill number and date of drawal of the loan. Date of encashment is to be intimated. In case of Non drawal/cancellation of Interest Free Medical Advance, the said fact will be reported to Government without fail. The unutilized amount if any should be refunded immediately.
