ORDER

- iv. State Quality Monitor (nominated by Chairman) - Shri.Roy J.Vellanikaran,

The committee may take decision on the grade improvement of each work based on the field verification conducted by SQM after carrying out appropriate tests and verification of the compliance of the observation of NQM. While considering the ATRs for grade improvement, the committee may also look into the reasons and justification for delay in furnishing the ATRs. The decision of the committee will be shared with NRRDA.


