**ORDER**

Sri.C.Baiju, Office Attendent, Block Development Office, Kilimanoor in his application read as 4<sup>th</sup> paper above has requested Government to sanction an amount of Rs.6,50,000/- (Rupees six lakh fifty thousand Only) as Interest Free Medical Advance for his kidney transplantation treatment at Amritha Institute of Medical Sciences and Research Centre, Kochi. The Commissioner for Rural Development has also recommended the application of Sri.C.Baiju, Office Attendent, vide letter read as 5<sup>th</sup> paper above.

Government have examined the matter in detail in the light of the Government Orders read above and are pleased to accord sanction for an amount of Rs.2,00,000/- (Rupees two Lakh only) as Interest Free Medical Advance to Sri.C.Baiju, Office Attendent, Block Development Office, Kilimanoor for his kidney transplantation treatment at Amritha Institute of Medical Sciences and Research Centre, Kochi by debiting the expenditure under the head of account "7610-00-800-95(02)- IFMA to Non Gazetted Officers" in the current year's Budget, subject to the conditions specified in the Government Orders read above. The Utilization Certificate duly countersigned by the Medical Officer of the Institution should be produced within 3 months from the date of drawal and the advance should be settled within 6 months. In case of default, penal interest @ 12% will be charged. Necessary entries regarding Interest Free Medical Advance will be made in the Service Book of the loanee with amount, number, date of the Government Order,

Contingent Bill number and date of drawal of the loan. The date of encashment is to be intimated. In case of Non drawal/cancellation of Interest Free Medical Advance, the said fact will be reported to Government without fail. The unutilized amount if any should be refunded immediately.
