ORDER

In the application read as 4<sup>th</sup> paper above, Sri.Sunil Kumar.G ,Chainman,Regional Town Planning Office ,Thiruvananthapuram has applied for an amount of Rs.1200000 - (Twelve lakh only) as Interest Free Medical Advance (IFMA) for his Kidney transplantation treatment at Lakeshore Hospital & Research centre , Kochi. The Chief Town Planner has recommended the application as per his letter read as 5<sup>th</sup> paper above. Dr.Abi Abraham. M, Sr. Consultant Nephrologist, Lakeshore Hospital has certified that total approximate expenditure for the treatment is Rs.1200000 - (Twelve lakh only ).

Government have examined the matter in detail and are pleased to sanction an amount of Rs.200000/- (Two lakh only) as Interest Free Medical Advance (IFMA) to Sri.Sunil Kumar.G ,Chainman,Regional Town Planning Office, Thiruvananthapuram for his Kidney transplantation treatment surgery at Lakeshore Hospital, Kochi subject to the conditions specified in Government Orders read as 1st to 3<sup>rd</sup> paper above and also on the following conditions. The expenditure in this regard shall be debited under Head of Account “7610-00-800-95(02) IFMA to Non-Gazetted Officers” in the current year's Budget.

- i. The Utilisation Certificate duly countersigned by the Medical officers of the Institution should be produced within 3 months from the date of drawal and the advance shall be settled within 6 months from the date of drawal. In case of default penal-interest @ 12% will be charged.
- ii. Necessary entries shall be made in the Service Book of the loanee regarding Interest Free Medical Advance with amount, number and contingent bill number, number and date of Government Order etc. of the drawal of the loan.

- iii. In case of non-drawal/cancellation of Interest Free Medical Advance the said fact may also be reported to Government without fail.
- iv. Date of encashment should be intimated.
- v. Unutilised amount if any should be refunded immediately.
