2.The Director of Health Services in the letter read as sixth paper above requested to accord permissive sanction to Grama Panchayats, Municipalities and Corporations in three districts Palakkad, Malappuram and Kasaragode to give financial support to the concerned CHC/PHC/Hospital for the above programme which is scheduled to be implemented from 14th December to 13th January 2016.

Municipalities	-	20,000/- (Rupees Twenty thousand only)
