ORDER

Smt.Anu R.S., Municipal Secretary, Pathanamthitta Municipality, as per the representation read as 1st paper above, has requested to promote her as Municipal Secretary Grade I, since she is the first among the gradation list for promotion to the post of Municipal Secretary Grade I and in view of the delay in convening of Departmental Promotion Committe (Higher). The Director of Urban Affairs, as per the letter read as 2nd paper above, has recommended to consider the request favourably.

- 2. Government have examined the matter in detail and are pleased to issue orders promoting Smt. On promotion, Smt. Anu R.S. is appointed as Municipal Secretary Grade I, Changanassery Municipality in the existing vacancy.
- 3. Following transfer and postings are also ordered in the cadre of Municipal Secretary Grade III in Urban Affairs Department for administrative convenience.
