Local Self Government Department – Kudumbashree – Establishment - Creation of the post of Accounts Controller on deputation basis in Kudumbashree National Resource Organization under NRLM – Sanctioned - Orders issued.

ORDER

As per letter read as 1st paper above, Government of India has issued the approved minutes of Empowered Committee of the National Rural Livelihood Mission Annual Action Plan (AAP) 2015-16 for the State of Kerala. As per letters read as 2nd above, the Executive Director, Kudumbashree has requested to create the post of Accounts Controller on deputation basis at Kudumbashree NRO to enable the compliance with the directions envisaged by the Empowered Committee of NRLM.

- (2) Government have examined the matter in detail and are pleased to accord sanction for creating the post of Accounts Controller in Kudumbashree NRO on deputation basis, subject to the following composition and conditions.
 - a) The salary of the Accounts Controller shall be met from the funds approved for Kudumbashree NRO for 2015-16. The funds to NRO shall be met entirely from the share of Government of India and there will be no financial commitment from the part of Government of Kerala.
 - b) The Accounts Controller shall be responsible for all financial approval and fund transfer related to all NRLP projects. The created post should be occupied by an officer of Gazetted rank.
 - c) The Chief Operating Officers of Kudumbashree NRO, COO of

Attappady Special Project and concerned Programme Managers of NRLP funded projects should be route all files related to financial matters directly to Executive Director, Kudumbashree through Accounts Controller. The Accounts Controller should be authorized to issue administrative and financial approvals up to Rs.50,000/- only.

- d) As the position requires control of Accounts and fund transfer, it will be essential that the Accounts Controller should have administrative experience. Hence during the selection of Accounts Controller a Gazetted Officer not below the rank of Under Secretary to Government may be given top priority.
- e) Selection of person to fill the position of Accounts Controller NRO will be done by a Committee chaired by the Principal Secretary, Local Self Government Department, Executive Director, Kudumbashree and the Chief Operating Officer, Kudumbashree NRO.
