As proposed by **Sri.Kovoor Kunjumon**, MLA representing **Kunnathur Constituency** under LAC-ADS, the Chief Engineer, PWD, Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work **Improvements to Pulinthitta Mukku – Chathamkulam Road from Ch 1/745 to 2/365** in **Poruvazhy Grama Panchayat** at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction.


