Road from Ch 850 m to 1562.40 m in Naranammoozhi Grama Panchayat  
under LAC-ADS at an estimate cost of Rs.25,00,000/- (Rupees Twenty Five Lac  
only) as per the reference read as 3<sup>rd</sup> paper above to accord Administrative Sanction.


