ORDER

As proposed by **Sri.Kovoor Kunjumon, MLA representing Kunnathur Constituency** under LAC-ADS, the Chief Engineer, PWD, Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work **Improvements to Mavelibhagam - Sahakarana Bank Junction Road from Ch 0/000 to 0/540 in Mynagappally Grama Panchayat** at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction. Mynagappally Grama Panchayat passed and forwarded resolution in this regard as per the reference read as 4th paper above.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work **Improvements to Mavelibhagam - Sahakarana Bank Junction Road from Ch 0/000 to 0/540 in Mynagappally Grama Panchayat** proposed under LAC-ADS of **Sri.Kovoor Kunjumon, MLA representing Kunnathur Constituency** at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** with Special Sanction to take up the work for execution as deposit work through PWD,


