ORDER

Sri.Abin.A.B, S/o.Late. Sri.B.S.Ajakumar, Former Driver Gr.I, Office of the Commissionerate of Rural Development, Thiruvananthapuram residing at B.S.Cottage, Plavila, Kairali Road, Nellivila.P.O, Thiruvananthapuram District as per his application read as 2nd paper above has applied for employment assistance under Compassionate Employment Scheme. The matter was enquired through the District Collector, Thiruvananthapuram and has recommended the request for employment assistance as per the report read as 4th paper above.

Sri.B.S.Ajakumar expired on 08.12.2012, while working as Driver Gr.I, Office of the Commissionerate of Rural Development, Thiruvananthapuram. He had put in a total service of 14 years at the time of his death. His son Sri.Abin.A.B. has applied for employment assistance under the scheme. All other dependents have relinquished their claim for employment assistance in favour of the applicant.

The District Collector, Thiruvananthapuram has recommended the applicant for appointment under the Scheme as L.D.Clerk in Rural Development Department. Sri.Abin.A.B. has passed Plus Two. He is aged 19 years. His date of birth is 28.09.1996 and family income was Rs12000/P.M. He has requested for appointment as L.D.Clerk in Rural Development Department in Thiruvananthapuram District. The applicant satisfies all the conditions for being appointed as L.D.Clerk.

In the circumstances reported by the Commissioner for Rural Development, Thiruvananthapuram and the District Collector, Thiruvananthapuram in their letters read as 3rd and 4th papers above and as per the provisions contained in the Government Order read as 1st paper above, sanction is accorded for the appointment of Sri.Abin.A.B. S/o.Late.

Sri.B.S.Ajakumar, Former Driver Gr.I, Office of the Commissionerate of Rural Development, Thiruvananthapuram residing at B.S.Cottage, Plavila, Kairali Road, Nellivila.P.O, Thiruvananthapuram District in the existing/ arising vacancy of L.D.Clerk in the Rural Development Department in Thiruvananthapuram District subject to the provisions governing the scheme. The Commissioner for Rural Development will issue formal posting orders to the applicant. Sri.Abin.A.B. will produce a copy of his photograph, recently taken, duly attested by a Gazetted Officer before the Commissioner for Rural Development at the time of joining duty. Before admitting him to duty, the original documents in proof of his age, educational qualification and medical fitness should be verified. His character and antecedents will also be got verified through the Police Department in due course. If the appointment is in a District other than the District of option for want of vacancy, he will be given transfer to the District of option in the next arising vacancy without loss of seniority. The five year rule prescribed for inter-district transfer of district-wise recruits will be made applicable in this case from the date of posting to the district of his choice. The details of appointment under the scheme will be entered in the Service Book of the deceased Government employee and also in the Establishment Register of the office in which the Government employee last worked and the fact will be attested by Head of office/Head of Department.

The appointment will be cancelled if and when it is found that there was misrepresentation or suppression of material facts at the time of applying for appointment under the Compassionate Employment Scheme or during the course of the enquiry by the departmental authorities.

Government will have the right to cancel the order sanctioning this appointment under the Compassionate Employment Scheme if, after the issue of the order, it is seen on examination that the orders were issued erroneously.
