ORDER

As per the letter read as 1st paper above, the Ministry of Urban Development. Government of India conveyed the sanction of the competent authority for the release of ₹1.75 crore to the State at the rate of ₹25 lakh per city/urban local body covered under AMRUT guidelines, as part of State Funds for Administrative & Office expenses (A&OE) for preparation of Service Level Improvement Plan (SLIP)/Capacity Building (CB).

The Project Director, Kerala Sustainable Urban Development Project (KSUDP), who has been appointed as the State Level Nodal Officer for the implementation of AMRUT project in the State of Kerala as per the Government Order read as 2nd paper above, has requested to take necessary action to release the aforementioned amount from the Budget Estimate 2015-16 as Central share, as per the letter read as 3rd paper above.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹1.75 crore (Rupees One crore seventy five lakh only) as central share from the budget estimate 2015-16 under the Head of Account "2217-05-800-75-(1) AMRUT", towards Administrative & Office Expenses (A&OE) for preparation of Service Level Improvement Plan (SLIP)/Capacity Building (CB), with permission to transfer credit the amount into the Special TSB Account bearing No. 26, maintained by the Project Director, KSUDP for Centrally Sponsored schemes with the Sub Treasury. Vellayambalam.
