Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work '**Improvements to Meenangadi-Ambalapadi -Meperikunnu Road**' in Meenangadi Grama Panchayath under LAC-ADS 2015-16 of **Sri.I.C.
