As proposed by Adv.K.Sivadasan Nair, MLA representing Aranmula Constituency under LAC-ADS for the year 2015-16 read as 3<sup>rd</sup> paper above, the Chief Engineer, PWD Roads & Bridges, Thiruvananthapuram has furnished detailed estimates of the work Construction of Protective Wall at Variyapuram - Priyadarshini Road in Elanthoor Grama Panchayat at an estimate cost of Rs.20,00,000/- (Rupees Twenty Lac only) as per the reference read as 4<sup>th</sup> paper above to accord Administrative Sanction.


