ORDER

As proposed by Smt.E.S.Bijimol, MLA representing Peermade Constituency under LAC- ADS, Kerala State Industrial Enterprises LTD, Thiruvananthapuram has furnished detailed estimate of the work Installation of Mini Mast Lighting Systems at 10 places in 4 Grama panchayats in Peermade Constituency at an estimate cost of ₹.15,00,000/- (Rupees Fifteen Lac Only) as per the reference read as 3rd paper above to accord Administrative Sanction and Special Sanction. The respective Local bodies passed and forwarded necessary resolution in this regard.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work, Supply, Installation and Commissioning of 10 Mini Mast Lighting Systems in 4 Grama Panchayaths in Peermade Constituency under LAC-ADS of Smt.E.S.Bijimol, MLA(Peermade) at a total estimate cost of ₹.15,00,000/- (Rupees Fifteen Lac Only) as detailed below with special sanction to take up the work for execution, as deposit work through Kerala State Industrial Enterprises LTD, Thiruvananthapuram following all departmental formalities and in tune with the guidelines issued in the Government Order read as 1st paper above and subsequent Government Orders. 
