**ORDER**

District Finance Inspection Squad, Kannur conducted an inspection at the office of the Block Panchayath, Kalliasseri on 12.7.2012 and detected certain serious irregularities in the implementation of Skill Development Training Programme under SGRY Scheme during 2011-12. As per read as 2<sup>nd</sup> paper above Sri.D.Johnson, Project Director, Poverty Alleviation Unit, Kannur has been suspended from service based on the recommendation of the report read as 1<sup>st</sup> paper above.

Against this Government Order Sri.D.Johnson submitted a review petition vide 3<sup>rd</sup> paper read above. In the petition he has stated, that his retirement prolongs only to 5<sup>1/2</sup> months and also requested to terminate his suspension period and reinstate him into service considering the short period of his retirement.

As per the Government Order read as 4<sup>th</sup> paper above, the suspension of Sri.D.Johnson is sustained until the completion of disciplinary proceedings initiated against him.

Government have examined the matter again in detail and are pleased to reinstate Sri.D.Johnson, former Project Director, Poverty Alleviation Unit, Kannur without prejudice to the pending disciplinary action taken against him. He is posted as Project Director, Poverty Alleviation Unit, Kollam in the existing vacancy.
