### ORDER

As proposed by Sri.V.D.Satheesan, MLA representing Paravur Constituency under LAC-ADS for the year 2015-16 read as 3<sup>rd</sup> paper above, the Chief Engineer, PWD Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work Providing Drainage Facilities in Pulikkathara Road & Kallumpuram Road in Chendamangalam Grama Panchayat at an estimate cost of Rs.25,50,000/- (Rupees Twenty Five Lac and Fifty Thousand only) as per the reference read as 4<sup>th</sup> paper above to accord Administrative Sanction.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work Providing Drainage Facilities in Pulikkathara Road & Kallumpuram Road in Chendamangalam Grama Panchayat under LAC-ADS of Sri.V.D.Satheesan, MLA representing Paravur Constituency for the year 2015-16 at an estimate cost of Rs.25,50,000/- (Rupees Twenty Five Lac and Fifty Thousand only) with Special Sanction to take up the work for execution as deposit work through PWD subject to resolution passed


