As proposed by Prof.C.Raveendranath MLA representing Puthukkad Constituency as per the letter read as 3rd paper above, the Chief Engineer, PWD Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work **Improvements to Manguttipadam - Monady Road in Mattathur Grama Panchayat** under LAC-ADS for the year 2015-16 at an estimate cost of **Rs.25,00,000/- (Rupees Twenty Five Lac only)** as per the reference read as 4th paper above to accord Administrative Sanction.


