As proposed by Dr.N.Jayaraj, MLA representing Kanjirappally Constituency as per the letter read as 3rd paper above, the Chief Engineer, PWD Roads & Bridges, Thiruvananthapuram has furnished detailed estimate of the work Providing cement Concrete Surfacing to CMI - Thumpamada Road in Kanjirappally Grama Panchayat under LAC-ADS for the year 2015-16 at an estimate cost of Rs.10,00,000/- (Rupees Ten Lac only) as per the reference read as 4th paper above to accord Administrative Sanction.


