**ORDER**

As per the Government Order read as 5<sup>th</sup> & 6<sup>th</sup> papers above, Administrative sanction was accorded for the work of re-construction of Laksham veedu houses constructed under M.N.Laksham Veedu scheme at an estimate cost of Rs. 100 lac ( LAC-ADS 2015-2016) and Rs.295 lac ( LAC-ADS 2014-2015) respectively of Sri. P.K.Kunhalikutty, Hon'ble Minister & MLA Vengara Legislative Assembly Constituency under LAC ADS as a special case.

As per the letter read as 7<sup>th</sup> paper above, Hon'ble Minister has requested to entrust Steel Industrials Kerala Limited (SILK) as executing agency to execute the above works.

Government have examined the matter in detail and are pleased to order that the works for which administrative sanction was accorded as per the Government Orders read as 5<sup>th</sup> and 6<sup>th</sup> papers above shall be executed as deposit work through SILK on the strength of resolutions passed by the

Concerned Local Bodies in this regard following all other formalities detailed in the said Government Orders.

The expenditure in this regard shall be debited to the head of Account "4515-00-800-96" projects under LAC-ADS (NP)". The Chief Engineer, Local Self Government Department should take necessary action to deposit the required amount to SILK, the executing agency, as envisaged in the circular read above.


