**ORDER**

Smt.M.A.Jancy, Extension Officer (Women Welfare), has submitted a representation before the Government as per 2<sup>nd</sup> paper read above, requesting to prepare the integrated seniority list based on the date of advice of entry post of Village Extension Officer and to effect necessary rectification in the final seniority list of Extension Officer Grade I.

As the representation is under active consideration of Government, she has filed O.A.NO.1853/15 before the Hon'ble Kerala Administrative Tribunal with the same request. The Hon'ble Kerala Administrative Tribunal in its order dated 18.11.2015 directed the 1<sup>st</sup> respondent (Secretary, Local Self Government Department) to consider and pass orders on Annexure A4 in accordance with law, after hearing the applicant and the 3<sup>rd</sup> respondent, within a period of three months from the date of receipt of a certified copy of this order.

In compliance to the order of the Kerala Administrative Tribunal, the applicant and the 3<sup>rd</sup> Respondent, Shri.Bijukumar, Joint Block Development Officer, Vadakkanchery, Thrissur were heard by the Under Secretary, Local Self Government (ERB) Department on 11.2.2016.

The Commissioner for Rural Development as per the 4<sup>th</sup> paper has reported that the integrated seniority list of Joint Block Development Officer, General

Extension Officer, Extension Officer (WW), Village Extension Officer Grade I was published as per 204575/Estt.B2/2012/CRD, dated 5.5.2014 based on the provisions in the Special Rule read as 1<sup>st</sup> paper above. The request of the applicant to consider the date of advice in the entry post for seniority cannot be considered as it is against Special Rule. The applicant has also admits that the person who has been advised after her was above her rank in the integrated seniority list as he has promoted Village Extension Officer Gr.I before her.

Government have examined the matter in detail in the light of Government Order read as 1<sup>st</sup> paper above. As per Rule 10 of amendment of Special Rule clearly specifies the integrated seniority list of the existing General Extension Officer, Extension Officer (H) Gr.II and Extension Officer (WW) shall be prepared according to the date of promotion of the incumbents to the respective posts. The integrated seniority list published as per 20575/Estt.B2/2012/CRD, dated 5.5.2014 of Joint Block Development Officer, General Extension Officer, Extension Officer (WW), Village Extension Officer Grade I are prepared based on the date of promotion in the respective post. The request of the applicant to consider the date of advice in the entry post for fixing seniority in the promotion post of Extension Officer is against the existing Special Rule. Therefore the Annexure A4 petition is rejected and thereby complying with the final order dated 18.1.2015 of the Hon'ble Kerala Administrative Tribunal in O.A.No.1853/15.
