## ORDER

The Water Supply Scheme of Municipal Corporation of Cochin, is covered under JnNURM. The revised estimate for the project is ₹252,80,17,511/- (Rupees Two Hundred and Fifty Two crore Eighty lakh Seventeen thousand Five hundred and eleven only) and the ULB share for the project had been fixed at ₹25,28,0000/- (Rupees Twenty Five crore and Twenty Eight lakh only). Out of this, the Corporation of Cochin had allotted an amount of ₹4,13,36000/- (Rupees Four crore Thirteen lakh Thirty Six thousand only) for the project, so far.

- 2. As per the letter read as 2<sup>nd</sup> paper above, the Secretary, Municipal Corporation of Cochin, has requested to accord special sanction to allocate an amount of ₹1,00,00000/- (Rupees One crore only) as the ULB share, from the unspent amount in the plan fund of the corporation for the year 2015-16.
- 3. Government have examined the matter in detail and are pleased to order as follows:
  - i) Permission is granted to the Municipal Corporation of Cochin to allocate an amount of ₹1,00,00000/- (Rupees One crore only) as the ULB share for the Water Supply Scheme of Municipal Corporation of Cochin, from the unspent amount in the plan fund of the municipality

for the year 2015-16, after following due procedure, subject to the present treasury restrictions.

ii) The Information Kerala Mission shall make necessary changes in the light of the above, in the software concerned.
