**ORDER**

Sri. Mohammed Basheer K., recruited through the Kerala Public Service Commission as Overseer Grade I, who subsequently promoted to the cadre of Assistant Engineer and joined duty as Assistant Engineer on 09/11/2001 FN has not passed the obligatory Departmental Tests during the normal period of probation in the cadre of Assistant Engineer. The Chief Engineer, LSGD reported that the incumbent has attained an age of 50 years on 01/03/2016 as his Date of Birth is 01/03/1962. Hence he is exempted from passing the obligatory Departmental Tests. As per the proceedings read as paper 2<sup>nd</sup> above, the Chief Engineer, LSGD has extended the period of probation of Sri. Mohammed Basheer K, Assistant Engineer up to 08.11.2004 AN and as per the letter read as paper 1<sup>st</sup> above, he has requested for the extension of the period of probation of the incumbent up to 02-03-2012 AN so as to declare the probation on 01-03-2012 FN. The Chief Engineer has reported that the incumbent is otherwise eligible to have declared the period of probation but for his non passing of the obligatory Departmental Tests.

2. ~~3~~. Government have examined the matter in detail. Sri. Mohammed Basheer K. has attained the age of 50 Years as on 29/02/2012 since his Date of Birth is 01/03/1962. Hence the Appointing Authority can exempt the incumbent from passing the obligatory Departmental Tests with effect from 01/03/2012 as per 4<sup>th</sup> proviso to Rule 13B, Part II, KS&SSRs and the period of probation can be declared to have been successfully completed as on 01/03/2012 FN.

3. ~~4~~. In the above circumstance, Government are pleased to extend the period for probation of Sri. Mohammed Basheer K., Assistant Engineer in the cadre of Assistant Engineer from 09/11/2004 to 02-03-2012 AN as per Rule 21 of Part II KS&SSRs, 1958.

4. ~~5~~. The Chief Engineer, LSGD will take further necessary action to permanently exempt Sri. Mohammed Basheer K., Assistant Engineer from passing the obligatory Departmental Tests with effect from 01/03/2012 as per 4<sup>th</sup> proviso to Rule 13B, Part II, KS&SSRs and to declare his period of probation as on 01/03/2012 FN.
