**ORDER**

As per the Government Order read above, sanction was accorded for entrusting the powers of delegation on all administrative and policy matters relating to the implementation of social welfare pensions to the Local Self Government Department for the speedy and effective disbursement of the pensions. Accordingly, the Social Justice Department has suggested to bring all heads of accounts connected to various social security pension schemes under the control of the Local Self Government Department.

Government have examined the matter in detail and are pleased to declare the Director of Panchayats as the Controlling Officer in respect of the following heads of accounts regarding social security pensions in Appendix IV as detailed in Column No.2 for withdrawal of funds from the respective heads of account in the Detailed Budget Estimates as detailed in Column No. 1.
