<u>ORDER</u>

- 2. As per the letter read as paper 2nd above, The Additional Chief Secretary to Government, Vigilance Department informed that the Suspension Review Committee held on 16/02/2016 decided to recommend reinstatement of the aforesaid Officers outside the District where the offence took place.
- 3. In view of the recommendation of the Suspension Review Committee, Government are pleased to reinstate Sri. G. Balachandran, Assistant Executive Engineer(under suspension) into service. On reinstatement he is posted as Assistant Executive Engineer in the Angamali Municipality in the existing vacancy.
- 4. As per the letter read as paper 3rd above, the Chief Engineer, LSGD informed that pursuant the recommendation of the Suspension Review Committee, Sri. M.T. Ganesan, Assistant Engineer(under suspension) was reinstated into service and posted as assistant Engineer in Kadannappally-Panappuzha Gramapanchayat, Kannur District, vide his proceedings No. E3/2100/08/CE/LSGD dated 14/03/2016. The action of the Chief Engineer in having reinstated Sri. M.T. Ganesan, Assistant Engineer into service is irregular as the order of his suspension was issued by the Government. However, in view of the recommendation of the Suspension Review Committee, Government

hereby ratifies the action of the Chief Engineer, LSGD in having reinstated Sri. M.T. Ganesan into Service.
