ORDER

Sri.M.Krishnadas, Village Extension Officer (appointed through
Employment Exchange) submitted a representation dated 8.3.2016
(Annexure-A9) before the Government to regularize him in the service
by invoking Rule 39 of KS&SSR. In the meantime he has filed
OA.561/2016 before the Hon'ble Kerala Administrative Tribunal. The
Hon'ble Kerala Administrative Tribunal in their Order read as 2nd paper
above, directed the Government to take a decision on Annexure A9
representation after hearing the applicant within a period of two
months from the date of receipt of a certified copy of the order,
especially since he has sought for relief under Rule 39 of Part II of
KS&SSR.

In compliance of the order of the Kerala Administrative Tribunal ,
the applicant was requested to appear for hearing on 24.5.2016 before
the Under Secretary, Local Self Government Department. The
communication was sent to the applicant through Registered post with
the address given in the application submitted by him on 10.4.2016.

But the applicant did not turn up for hearing. Later the communication was seen returned on 6.6.2016 without being delivered with note that the addressee is not known.

The Commissioner for Rural Development as per read as 3rd paper above has reported that the applicant was appointed as Village Extension Officer through the Employment Exchange and he was terminated from service on expiry of 179 days service. As per rule 9(a) (i) of KS&SSR any person appointed through Employment Exchange in a post temporarily, could not be continued in that post for a period exceeding 179 days.

Government have examined the matter in detail. The request of the applicant to regularize him in the service after getting appointment through Employment Exchange is against the existing Rules and hence it cannot be considered. Therefore the A9 petition is rejected and thereby complying with the final order of the Hon'ble Kerala Administrative Tribunal dated 16.3.2016 in O.A.561/2016.
