ORDER

The Kerala Public Service Commission, as per the letter read above, has advised the following candidates for appointment to the post of Health Officer Grade-III/Lady Medical Officer/Assistant Health Officer on Rs.20,740-36,140 (Pre-Revised) in Municipal Common Service.

- (a) Smt. Renu Swamidas, 7B Cliff Dale, Nanthencode, Kowdiar P.O., Thiruvananthapuram - 695 003.
- (b) Shri. Sasi Kumar A., C/o P. Rajan, Stagbrook Estate, Peermade PO., Idukki-685 531.

2. In this circumstance, the above candidates advised by Kerala Public Service Commission are provisionally appointed to the post of Health Officer Grade-III/Lady Medical Officer/Assistant Health Officer on Rs.39,500-83,000/- [Rs.20,740-36,140 (Pre-Revised) in Municipal Common Service and are appointed as Health Officer Grade III in the respective Corporations noted against their names.

- (a) Smt. Renu Swamidas - Kochi Corporation
- (b) Shri. Sasi Kumar A. - Thiruvananthapuram Corporation.

3. The appointment of the candidates is subject to Rule 3(c) of the General Rules of Kerala State & Subordinate Service Rules, 1958.

4. The candidates shall report before the Secretaries of concerned Corporations with relevant records in proof of age, qualification, Community Certificate etc. within 15 days from the date of receipt of the order and the Secretaries of Corporations concerned should verify the records before he/she is admitted to duty. The Secretaries of Corporation should obtain a Medical Certificate from the candidate as prescribed in G.O.(P.) No.20/2011/P&ARD dated 30.6.2011 before appointment. As ordered in G.O.(Ms) No.170/74/PD/Public Services (D) dated 18.07.1974, the appointing authority has to obtain the necessary details of the candidates duly filled up in the prescribed proforma and to make necessary arrangements for the verification of character and antecedents of the candidates. But before the character and antecedents of the candidates are verified, the appointing authority may appoint any candidate mentioned in the letter temporarily under clause (1) of sub rule (a) of Rule 9 of the General Rules as provided for in Rule 10(b) of those rules (vide G.O.(P) No.49/74/PD dated 05.03.1974). The signature of the candidates on the passport size photograph affixed to the Identification Certificates and the photograph should be verified by the Secretaries of Corporations and the fact may be recorded on the Scanned Copy of Identification Certificate itself. The date of birth and qualifications of the candidates shall be verified before he/she is admitted to duty. In the case of candidate whose community is also noted, the same may be verified with prescribed community certificates. If there is any discrepancy, the candidates should not be allowed to join duty and the fact should be reported forthwith. After the candidate is allowed to join duty, the Scanned Copy of Identification Certificate verified and found acceptable may be kept pasted in his/her Service Book.

5. The Director of Urban Affairs shall also forward the proforma for verification of character and antecedents to Government in due course. The appointment shall be regularized only after obtaining a verification certificate from Kerala Public Service Commission. For this purpose, the Director of Urban Affairs shall forward an attested copy of the relevant pages of Service Book of the incumbent to Government as ordered in G.O.(P.) No. 20/2011/P&ARD dated 30.6.2011.

6. In the event of discharge from service for want of vacancies, the candidate may either re-register his/her name in the Office of the Public Service Commission/District Office of the Public Service Commission from where he/she was advised and get himself/herself re-appointed on further advice by the Public Service Commission or he/she may wait for his/her turn for re-appointment to the

post in the Department, in case he/she desires to continue as probationer in the posts from which he/she is discharged (vide Government Circular Memorandum No. 3737/Rules-1/90/P&ARD dated 29.3.1990 and G.O.(P) No.7/91/P&ARD dated 15.2.1991).

7. The Originals of Non Creamy Layer Certificate of Smt.Renu Swamidas and Community Certificate of Shri. Sasi Kumar A. should be verified at the time of their joining duty.
