ORDER

The Hon'ble Kerala Administrative Tribunal, as per the interim order read as 4th paper above, has directed the first respondent (Principal Secretary, Local Self Government Department) to take a decision on Annexure A2 and A3, before the applicant retires on 31.05.2016. Annexure A2 and A3 are representations read as 1st paper above, submitted by Sri. P. Muraleedharan requesting to grant him provisional promotion to the post of Municipal Secretary Grade I.

2. Shri.P.Muraleedharan has been served with Memo of Charges for minor penalty as per the letters read as 1st and 2nd papers above.

3. Government examined the case. The officers who are facing disciplinary action for minor penalty can be granted provisional promotion only if the Departmental Promotion Committee decides to include them in the Select List. The seniority list of Municipal Secretary's is being prepared by Government. In the circumstances, the request of Shri.P.Muraleedharan to grant him provisional promotion to the post of Municipal Secretary Grade I cannot be considered and representations read as 1st paper above is hereby rejected.

4. The interim order of the Hon'ble Kerala Administrative Tribunal read as 4th paper above is complied with accordingly.
