**ORDER**

Administrative Sanction was accorded for the work of Kalluvalappu-Pathikkal Road included in PMGSY 2008-09 (Phase VII) Package No. KR 04-21, Kuthuparamba Block, Kannur District for an amount of Rs. 3,78,14,000/- (Rupees Three crore Seventy eight lakhs fourteen thousand only) vide Government order read as first paper above.

2) As per Government order read as 2<sup>nd</sup> paper above, the estimate for the work has been revised based on SOR 2010 for an amount of Rs.4,59,10,000/ and technically sanctioned by the Superintending Engineer, KSRRDA for the same amount and the work was awarded at 38.50% above estimate rate.

3) Now, the Chief Engineer, Kerala State Rural Roads Development Agency, as per the letter read as 4<sup>th</sup> paper above has reported that during execution certain deviation from the sanctioned estimate were found necessary for the proper completion of the work and submitted a revised estimate amounting to Rs. 7,45,88,461/- against the sanctioned estimated PAC of Rs. 4,57,32,740 /- with an additional amount of Rs.

2,88,55,721/- and requested for revised Administrative Sanction. The Chief Engineer has also informed that National Rural Roads Development Agency, New Delhi, Government of India, has given no objection to the proposal vide 3<sup>rd</sup> cited.

4) Government have examined the matter in detail and are pleased to accord revised administrative sanction for the work Kalluvalappu-Pathikkal Road included in PMGSY 2008-09 (Phase VII) Package No. KR 04 21, Kuthuparamba Block, Kannur District for an amount of Rs. 7,45,33,461 (Rupees Seven Crore Forty five lakhs Eighty eight thousand Four hundred and Sixty one only) against the sanctioned amount of Rs. 4,57,32,740/- by meeting the additional amount required over and above the estimate i.e., Rs. 2,88,55,721/- from the savings of Phase VII PMGSY roads in Wayanad District subject to the condition that no additional funds would be given on this account.
