ORDER

28 Municipalities have been formed in the State as per the Government Orders read as 1st and 2nd papers above. 48 posts have been sanctioned at Anthur Municipality, as per the Government Order read as 4th paper above. The Director of Urban Affairs, as per the letter read as 3rd paper above, has requested to create bare minimum of 47 posts each in the newly created 27 Municipalities, except Anthur Municipality, for the smooth functioning of the Municipalities.
